2018 LAURIE CARR SCHOLARSHIP **Program Details**

A. SCHOLARSHIP

Up to \$2,000 in scholarships per year may be awarded at the determination of the SPHA Board.

B. ELIGIBILITY

- 1. Applicant must be a resident of South Portland Housing Authority (SPHA) owned or managed property, or a recipient of an HCV voucher (Section 8) under the jurisdiction of the SPHA.
- 2. Applicant must be currently attending or planning to attend a certification, license, or degree earning program. Veterans, non-traditional students and traditional students are encouraged to apply.

C. APPLICATION SUBMISSION

- 1. Completed Application.
- 2. Verification of acceptance into a certification, license or degree earning program, or application/acceptance status.
- 3. A typed, 250 minimum word essay discussing "Why this training/education, why now?" Applicant may provide a sample of their personal work as an alternate submission in lieu of essay or in addition to a shorter essay. This alternate submission should address the topic.
- 4. Two letters of recommendation from non-relatives required.
- 5. Applicants currently attending a high school, college, or other program should provide a transcript of grades from high school or college they are presently attending. Certificates of completion are also acceptable. Transcript not needed for applicants currently participating in an apprenticeship program.

D. AWARD PROCESS

- 1. Application submitted to Scholarship Committee between March 15, 2018 and May 2, 2018.
- 2. Any application that is incomplete or missing appropriate submittals will be disqualified.
- 3. Screening, evaluation and selection will be conducted by the Scholarship Committee, with final award decision approved at an SPHA Board Meeting.
- 4. Successful applicant(s) will be notified by **May 30, 2018**.
